### APPLICATION FOR REVIEW OF DECISION UNDER THE GAS PIPELINES ACCESS (QUEENSLAND) ACT 1998

#### A GUIDE

Please read the following information carefully before submitting your application for a review of a decision under the *Gas Pipelines Access (Queensland) Act 1998*.

#### ***How to apply for a review of a decision***

An application for review may be submitted to the Registrar of the Queensland Gas Appeals Tribunal by completing (in full) the prescribed Application Form (you may attach additional information if needed).

#### ***Which decisions may be reviewed?***

The Queensland Gas Appeals Tribunal has jurisdiction over the following types of decisions made by the Queensland Competition Authority in relation to distribution pipelines for natural gas:

- ring fencing;
- access arrangements;
- associate contracts; and
- information disclosure.

Please refer to the legislation in order to determine whether the decision you wish to have reviewed falls within the jurisdiction of the Tribunal. **A separate application is required for each decision you wish to have reviewed.**
